ANNOUNCEMENT OF ALLOTMENT RESULTS

SUMMARY

Net Proceeds from the Share Offer

- Based on the Offer Price of HK\$0.25 per Offer Share (exclusive of brokerage of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%), the net proceeds from the Share Offer to be received by the Company, after deduction of underwriting fees and commissions and estimated expenses payable by the Company in connection with the Share Offer, are estimated to be approximately HK\$42.5 million. The Company intends to apply such net proceeds in accordance with the purposes as set out in the section headed “Net Proceeds from the Share Offer” in this announcement.

Applications under the Public Offer

- The Offer Shares initially offered under the Public Offer have been very significantly over-subscribed. A total of 17,548 valid applications have been received pursuant to the Public Offer for a total of 1,864,870,000 Public Offer Shares, representing approximately 37.30 times of the total number of 50,000,000 Public Offer Shares initially available for subscription under the Public Offer.
- Since the over-subscription in the Public Offer is more than 15 times but less than 50 times of the number of Offer Shares initially available under the Public Offer, and the Offer Shares initially available under the Placing was slightly over-subscribed by approximately 0.13 times, the reallocation mechanism as disclosed in the paragraph headed “Structure of the Share Offer – Reallocation between the Placing and the Public Offer” in the Prospectus has been applied and 100,000,000 Offer Shares have been reallocated from the Placing to the Public Offer. As a result of such reallocation, the final number of Offer Shares allocated to the Public Offer is 150,000,000 Offer Shares, representing 30.0% of the total number of Offer Shares initially available under the Share Offer.

The Placing

- The Offer Shares initially offered under the Placing have been slightly over-subscribed by approximately 0.13 times. The final number of Offer Shares under the Placing is 350,000,000, which is equivalent to approximately 77.7% of the total number of 450,000,000 Placing Shares initially available for subscription under the Placing.
- The final number of Placing Shares allocated to 146 placees under the Placing is 350,000,000 Placing Shares, representing 70.0% of the total number of Offer Shares available under the Share Offer. A total number of 18 placees and 48 placees have been allotted one board lot and five board lots or less of Offer Shares, representing approximately 12.3% and 32.9% of the total number of 146 placees under the Placing, respectively. These placees have been allotted 0.05% and 0.26% of the Offer Shares available under the Placing, respectively.

- The Directors confirm that no Offer Shares have been allocated to applicants who are core connected persons (as defined in the Listing Rules), directors, existing shareholders of the Company or existing beneficial owners of the Shares and/or any of the Company’s subsidiaries, or their respective associates (as defined in the Listing Rules), whether in their own names or through nominees. None of the Sole Sponsor, the Sole Global Coordinator, the Joint Bookrunners, the Joint Lead Managers and their respective affiliates, companies and connected clients of the lead broker or of any distributors (as defined in paragraph 5(1) of Appendix 6 to the Listing Rules) or persons set out in paragraph 5(2) of the Placing Guidelines, whether in their own names or through nominees, have taken up any Placing Shares for its own benefit under the Placing. No placee will, individually, be placed more than 10% of the enlarged issued share capital of the Company immediately after the Share Offer. None of the placees under the Placing will become a substantial shareholder (as defined in the Listing Rules) of the Company after the Placing. The Directors confirm that (i) the three largest public Shareholders do not hold more than 50% of the Offer Shares held in public hands at the time of the Listing in compliance with Rules 8.08(3) and 8.24 of the Listing Rules; (ii) the Offer Shares will be held by at least 300 shareholders at the time of Listing in compliance with Rule 8.08(2) of the Listing Rules; (iii) the number of Offer Shares in public hands and the market capitalisation of the number of shares to be held by the public will satisfy the minimum requirement prescribed under Rule 8.08(1) of the Listing Rules; and (iv) none of the Offer Shares subscribed by the placees and the public has been financed directly or indirectly by any of the Directors, chief executives of the Company, substantial Shareholders, Controlling Shareholders, existing Shareholders or any of its subsidiaries or their respective close associates, and none of the placees and the public who has subscribed for the Offer Shares is accustomed to taking instructions from any of the Directors, chief executives of the Company, the substantial Shareholders, Controlling Shareholders, existing Shareholders or any of its subsidiaries or their respective close associates in relation to the acquisition, disposal, voting or other disposition of the Shares registered in his/her/its name or otherwise held by him/her/it.
